RECOMMENDATIONS

6.1 Introduction

It is apparent from Section 3 that whilst secondary impacts have and continue to be identified from roads and road transport, many issues are poorly understood and there are gaps in the information. This section focuses on recommendations for further research, the aim of which would be to provide improved guidance, both regarding potential impacts and possible mitigation measures.

6.2 NEED FOR FURTHER RESEARCH

Further research is required in many areas including the following:

- a fuller understanding of the impacts;
- the interaction between combinations of impacts (eg fragmentation, noise and artificial lighting);
- the cumulative impacts resulting from the above and also from a number of different road schemes;
- effectiveness of current mitigation;
- costs associated with provision of mitigation and proportional benefits to wildlife and costs of inadequate mitigation;
- proposals for improved mitigation;
- predictive techniques for allowing wider analysis at the planning stages.

Many of the above would benefit from a greater commitment on behalf of highways agencies to monitoring of the "before, during and after" situations.

Options for further research are presented in *Table 6.2a* below and the work proposed by the Highways Agency is highlighted in *Section 6.3*.

Other issues which should be encouraged are:

- increased Strategic Environmental Assessment (SEA) to permit more accurate identification of the cumulative impacts of road schemes;
- more detailed consideration of secondary issues in EAs at the earliest possible stage in the planning process;
- notification of badgers as a road traffic hazard which would make the need for incorporation of mitigation measures compulsory, as is the case for deer;
- long term monitoring of road schemes covering "before, during and after" scenarios.

6.3 PROPOSED RESEARCH

It is understood that the Highways Agency proposes the following areas for research which will commence in 1996 or 1997 (*pers comm* Highways Agency, 1995):

- assessment of impacts of new or improved roads on wildlife in terms of road
 casualties with the aim of developing methods to better predict where
 casualties are most likely to occur so that mitigation can be targeted
 properly; and
- impacts of recently constructed roads on protected sites such as NNRs and SSSIs with particular emphasis on the success of mitigation measures (including grassland translocation).

Additional work may also be proposed including on otters, bats and great-crested newts if resources are available.

Where other research is already ongoing into a particular topic this has been noted in the preceding text.

The following conclusions can be drawn from this study:

- secondary impacts to nature conservation from roads and road transport are recognised, however, they are on the whole poorly understood;
- central to this is the lack of research on specific issues which stems from the
 traditional lack of commitment (and resources) by organisations with
 highways responsibilities (eg DoT, Highways Agency, County Councils etc)
 into funding such work many of these organisations are, however,
 beginning to reverse this trend;
- cumulative impacts are rarely considered although increasing commitment to strategic environmental studies will improve the level of understanding of these impacts;
- coverage of secondary issues in environmental assessments (EAs) of road developments has to date been sporadic and not comprehensive;
- fragmentation, isolation and associated effects (eg wildlife casualties) are key issues and have been more extensively studied, however, understanding of the significance of wildlife casualties on populations for example, typically remain unanswered;
- impacts from individual road schemes differ and more detailed research in before, during and after situations are required;
- mitigation options may be based on strategic measures such as, policy decisions to help reduce air pollution and/or specific measures such as wildlife passages to reduce fragmentation impacts and wildlife casualties;
- the success of mitigation measures which are implemented is rarely investigated and thus, the impacts of "mitigated schemes" are seldom certain;
- the requirements for further research are numerous and a focused programme of research is recommended - key issues include the implications of:
 - fragmentation/isolation and associated effects such as barrier effects, wildlife casualties, edge effects, buffer zones etc;
 - noise and lighting impacts including effects outside human detection levels eg ultra and infra frequencies;
 - air pollution effects on fauna;
 - management of roadside verges for nature conservation;
 - cumulative impacts including predictive techniques;
 - monitoring the success of current mitigation measures.
