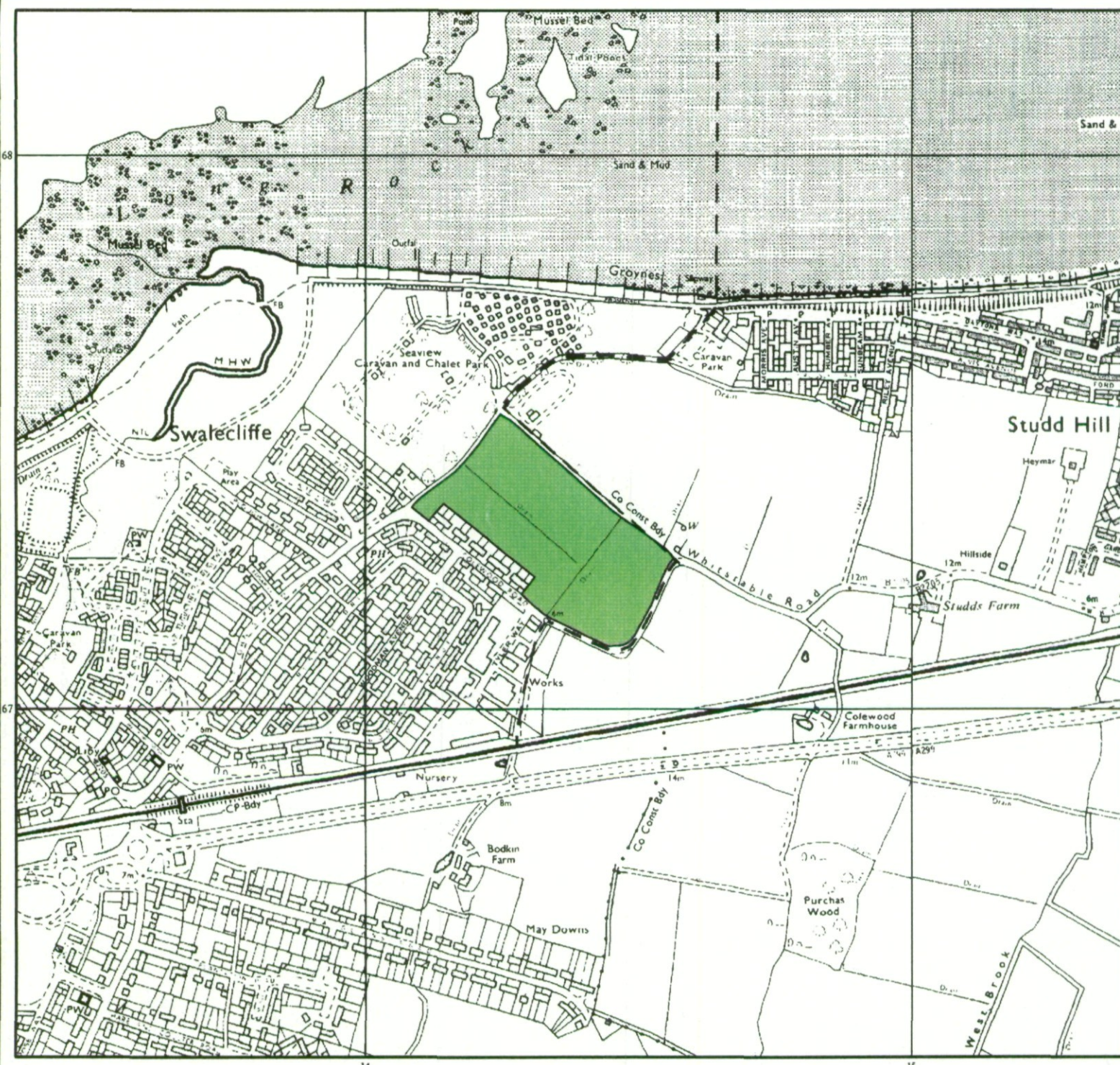

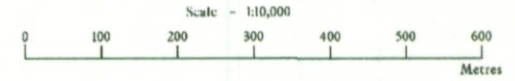

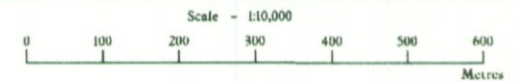
SAMPLE POINT MAP
