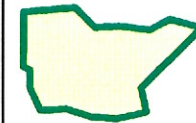

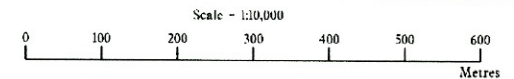
Sample Point Map

- 1 Location of auger sample point

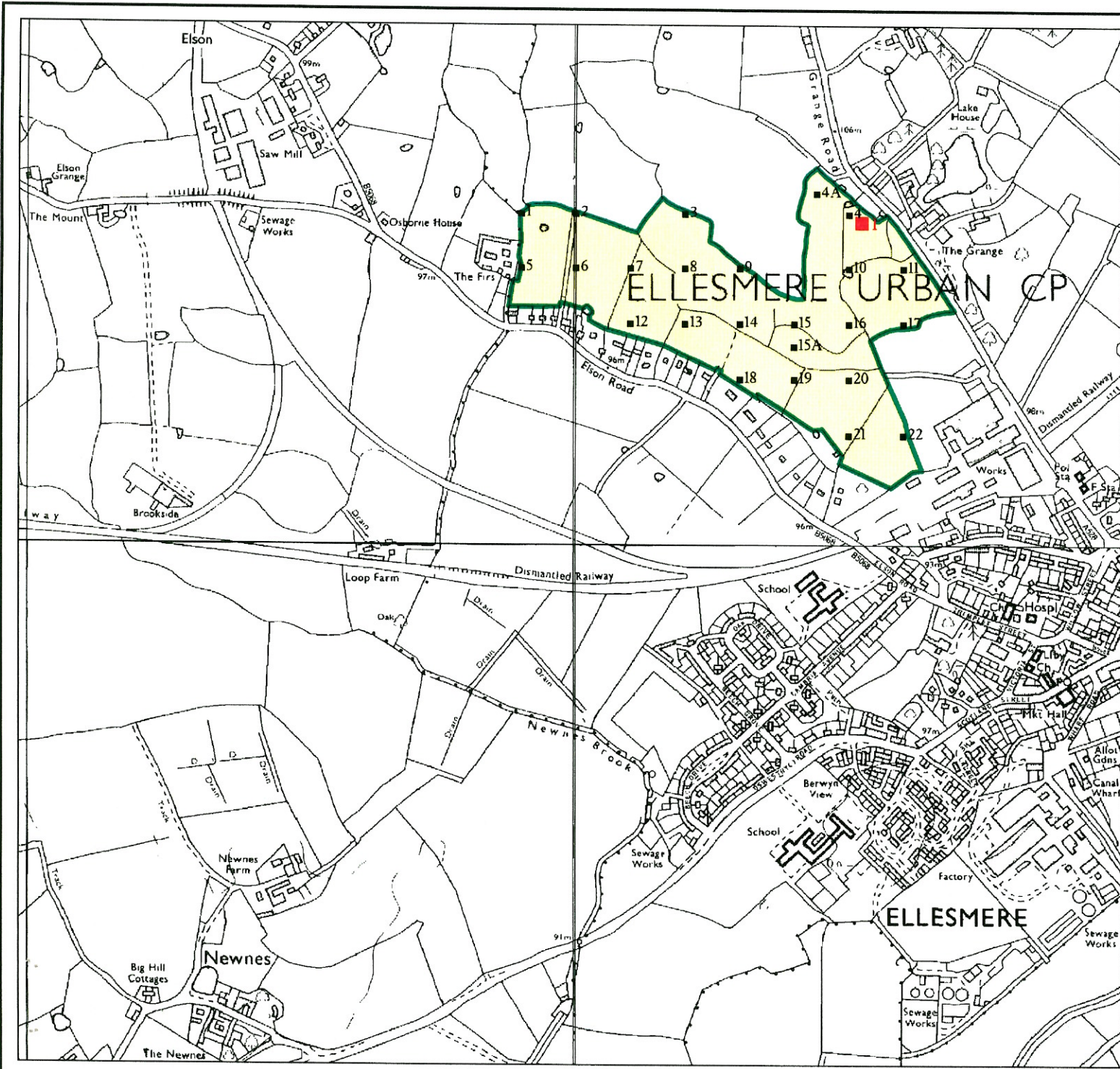


Boundary of survey area

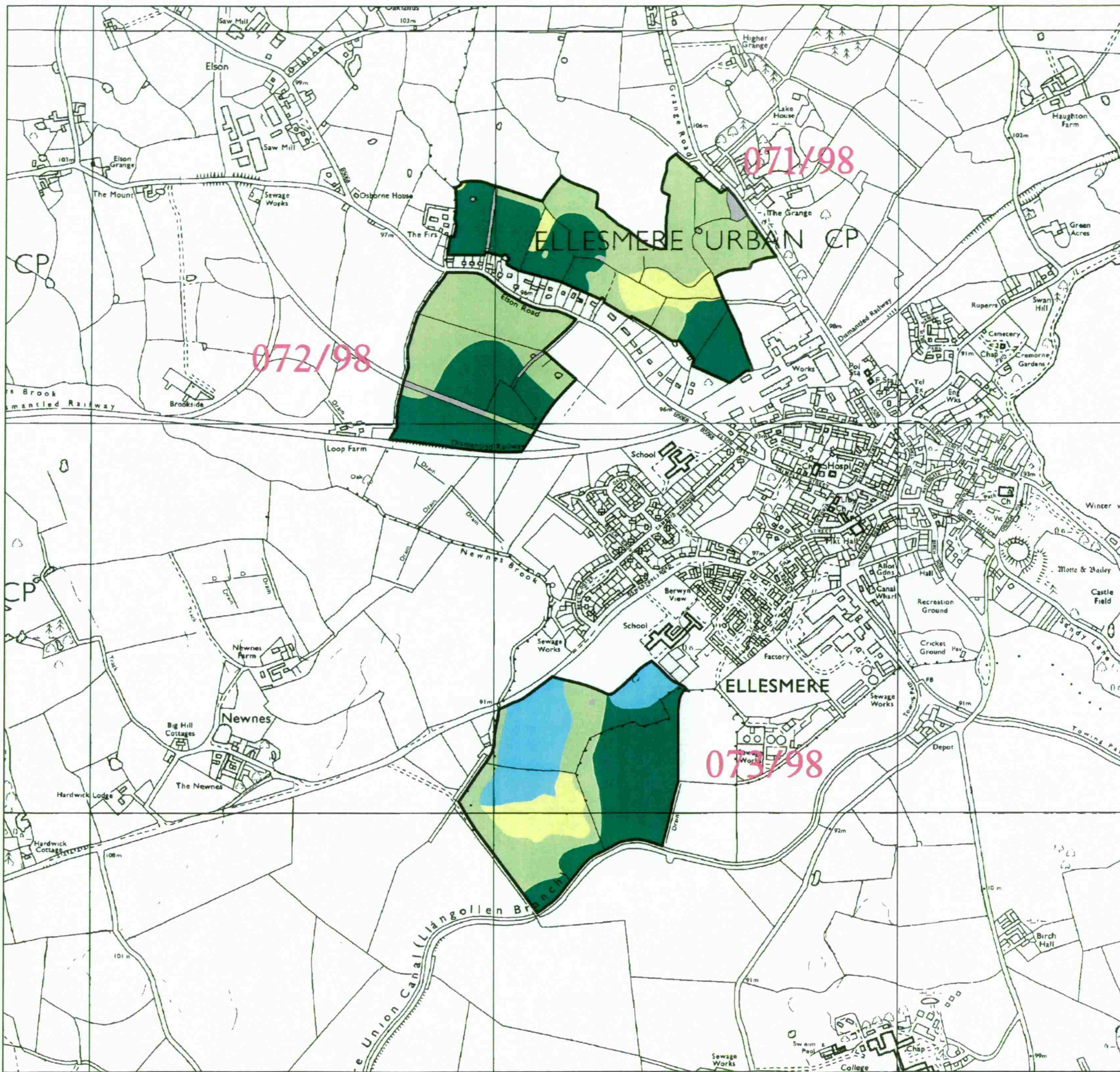

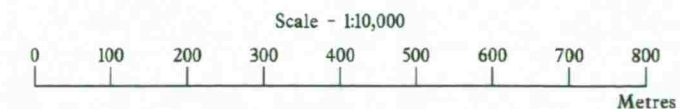


Agricultural Land Classification Shropshire Structure Plan Ellesmere - Composite

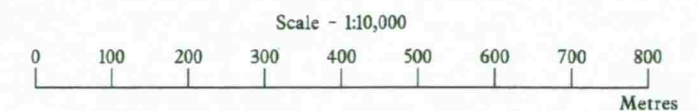
Sample Point Map
