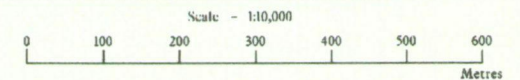





SAMPLE POINT MAP

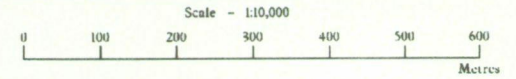
-  LOCATION OF SOIL PIT
