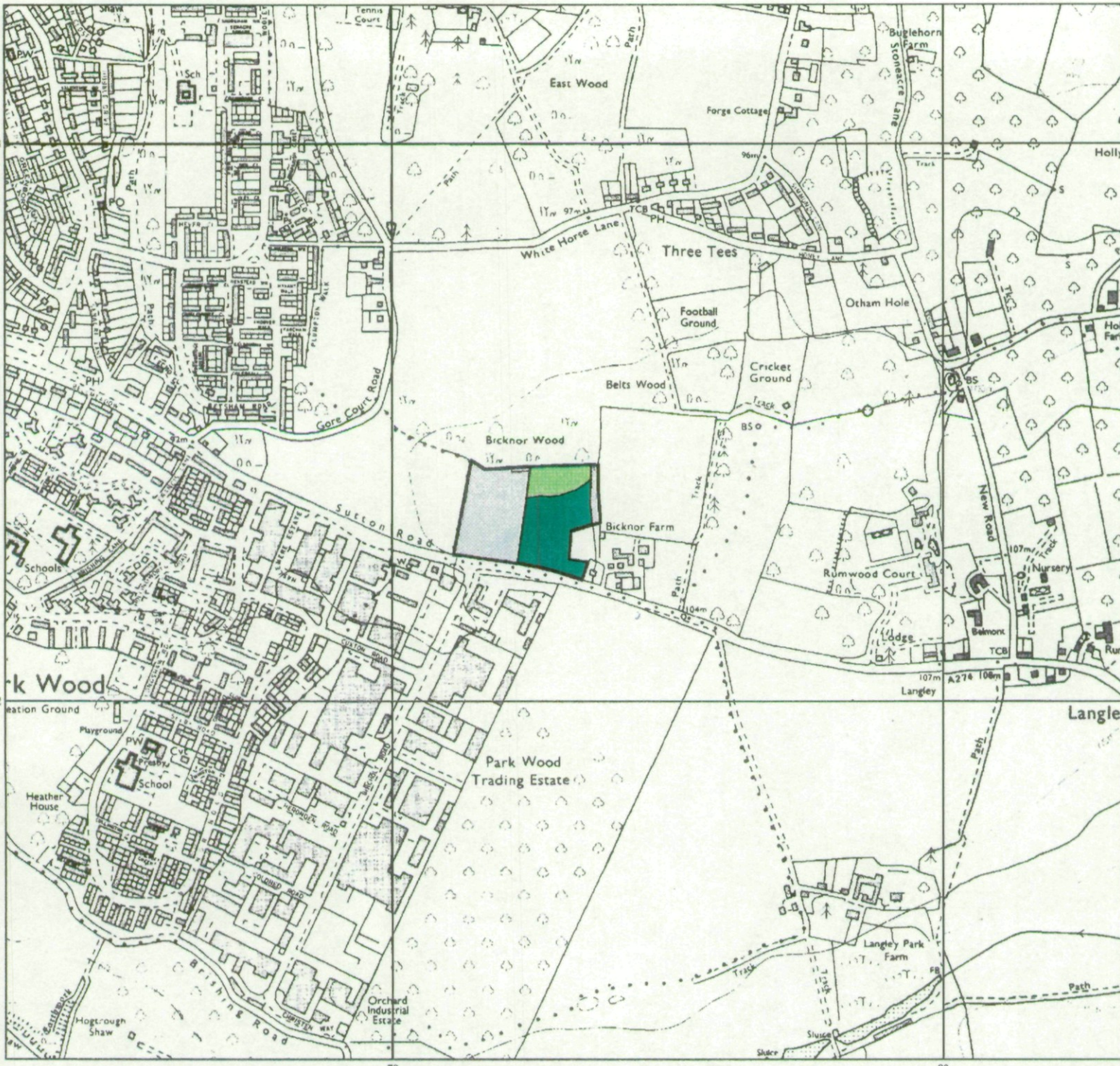


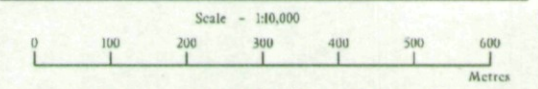

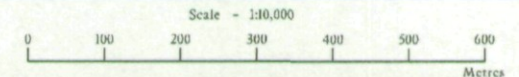
### SAMPLE POINT MAP
